CONDITIONS

The issue of a Sale of Goods Permit is subject to the following conditions or such other conditions as the Council may specify.

1. That pedestrian access is not restricted by the goods.
2. The permit holder shall ensure that it is licensed or registered to carry out the activity authorised by the issuing of this permit.
4. The permit holder must carry with them a copy of the permit and show it to Council and/or Police Officers on request. Instructions issued by Council or Police Officers must be obeyed without exception.
5. The permit activity can only be conducted at locations approved by Council and specified within the permit.
6. No more than two people can be grouped at the same location for the approved activity and the permitted activity must be confined to the immediate vicinity of that location.
7. The permit is not transferable.
8. The permit holder will not promote any discriminating, insulting, offensive, threatening or vulgar behaviour or displays.
11. All conditions of the permit must be adhered to. Failure to comply with the conditions automatically revokes the permit and the activity must cease immediately. The Council reserves the right to revoke the permit at any time.
12. The permit holder accepts that Council has no responsibility whatsoever for any bodily injury to the permit holder or any other person at the activity location or for any damage to or loss of property and equipment owned by the permit holder or any other person at the activity location. Consequently, the permit holder accepts responsibility for any negligence arising from the use of the activity location for which the permit holder has reasonable control.

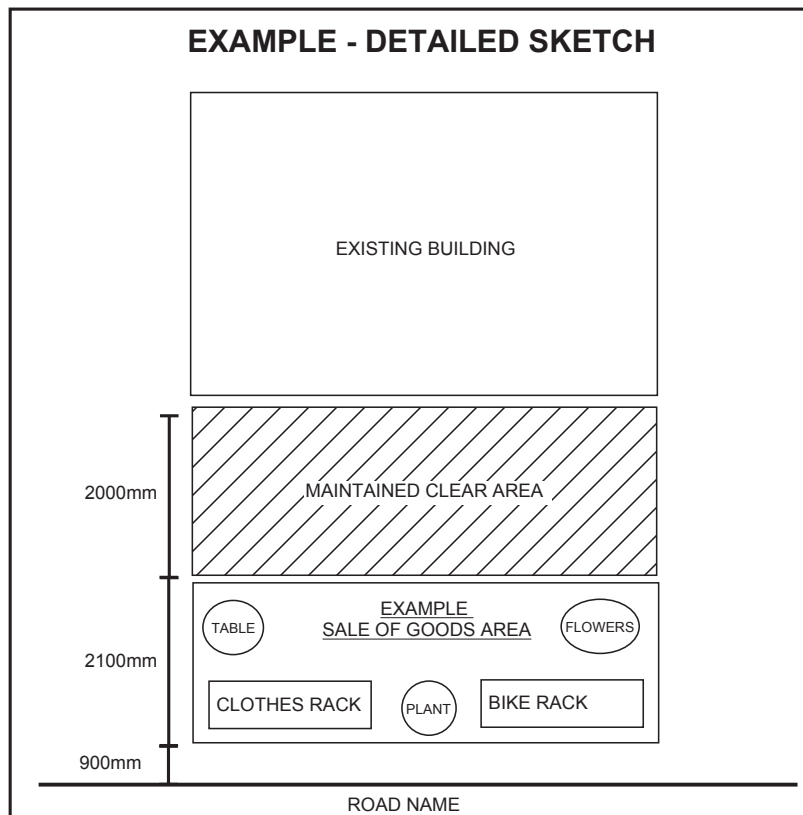
